

RESOLUTION NO. 768
(2009 Series)

WHEREAS, the Town of Fowler owns, operates and maintains a sanitary sewer system that provides service to residents inside and outside the Fowler town limits; and

WHEREAS, Fowler Municipal Code section 13.08.010 provides that sanitary sewer rates shall be set by the Board of Trustees from time to time by resolution; and

WHEREAS, the Board of Trustees has determined that sanitary sewer rates must be increased in order to cover increased operational costs of the sanitary sewer system; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF FOWLER, COLORADO AS FOLLOWS:

a. **SANITARY SEWER MONTHLY CHARGES FOR USERS INSIDE THE TOWN LIMITS**

- 1 Sanitary sewer rates for customers receiving sanitary sewer service within the municipal boundaries of the Town of Fowler shall be as follows effective January 1, 2010 which date is a minimum of thirty days subsequent to publication of this resolution as required under Fowler Municipal Code section 13.08.070.

A \$17.00 per tap per month

b. **SANITARY SEWER MONTHLY CHARGES FOR USERS OUTSIDE THE TOWN LIMITS**

- 1 Sanitary sewer rates for customers receiving sanitary sewer service outside the municipal boundaries of the Town of Fowler shall be as follows effective January 1, 2010 which date is a minimum of thirty days subsequent to publication of this resolution as required under Fowler Municipal Code section 13.08.070.

A \$24.50 per tap per month

- c. To the extent required or necessary any resolution previously adopted which is inconsistent herewith, is hereby repealed, revoked or modified.
